#### Nature on the Common - late summer

The Common looks particularly beautiful this summer. Golden drifts of barley shift with the winds, while butterflies and bees are more abundant than usual. The Common is flourishing in this year's absence of Midsummer and Strawberry Fairs. While the fairs are short in duration, the thousands of attendees that they attract cause damage to the Common that persists for the rest of the summer. Without this pressure in 2020, the Common has returned to a more natural state, with daily benefits to us all.

# Point of View – Let's reconsider the Guy Fawkes bonfire. Can we reconcile a giant bonfire with a concern for health and climate?

Midsummer Common has hosted a number of activities over the centuries that have been discontinued as our attitudes, values and priorities have changed. The FoMC Committee believes it is time to ask if the Guy Fawkes' night bonfire makes sense this year, during the pandemic, and in the future, given the health concerns for individuals and the climate.

As the Covid-19 pandemic continues, the wisdom of a November 2020 mass gathering must be questioned. As to the future, city regulations already prohibit bonfires because the materials burned produce toxic pollutants. These emissions can have damaging health effects for those with lung and heart conditions. In addition, the scorching and scarring of a large patch on the Common remains all year.

# **Streams through the Common?**



Imagine the biodiversity that would come from flows of water through the Common. In fact, nineteenth century maps show that 'ditches' on the Common channelled water into the Cam and that bridges were in place to accommodate both people and cattle. One ditch flowed eastwards across Jesus Green with its own tributary coming from Butt Green and joining the Cam near the Fort St George. The other started on Midsummer Common and flowed eastwards joining the Cam near Walnut Tree Avenue.

Although these ditches have been covered and underground pipes now conduct the flow of water, the FoMC Committee believes it may be possible to re-expose the ditches in whole or in part. Ample sections of buried pipe would remain as crossing points for people and cattle. This has already been accomplished at Logan's Meadow (see the photo at left), to the benefit of species like the water vole, dragonfly, damselfly, moorhen, kingfisher, soprano pipistrelle and other bats.

# **Open issues for FoMC**

These are some of the issues engaging the FoMC in 2020:

- 1. Bramble, nettle, thistle management. These provide benefits for wildlife, but act as barriers to access for both people and cattle. A better management plan is needed.
- 2. Midsummer Fair week-end. Although the fair was cancelled, impromptu gatherings took place. This year featured widespread littering, broken bottles, urinating in public and a few confrontations with threats of violence. How can management of this weekend be improved for 2021?
- 3. The committee will refine and complete a Management Plan for 2019 2024. New objectives include increasing the number and variety of trees and enhancing the species richness and diversity of the grassland. The latest draft of the plan is posted at:
